Mrs. Harris is a mentor, and has created a mentoring program that supports articling students within the Ministry of the Attorney General through the stress and isolation of the COVID-10 pandemic.

"Update from the Associate Chief Justice of the Superior Court of Justice "

The Honourable Faye E. McWatt was born in Georgetown, Guyana, and immigrated to Canada in 1962. Justice McWatt received her Bachelor of Laws (LL.B.) from the University of Ottawa in 1984 and was called to the Ontario Bar in 1986. She practised criminal law as a Crown attorney, then as a criminal defence lawyer. In 1995, she was appointed as an agent for the federal Department of Justice and began prosecuting federal narcotics offences. Justice McWatt acted as counsel before various commissions of inquiry as well. In 2000, Justice McWatt was appointed to the Superior Court of Justice of Ontario, where she has presided over criminal, family, and civil law cases.
